Ms. Yates, Executive Director of the Cedar Rapids Civil Rights Commission, provided an update on the caseload report and director's report.

- The Public Sector Job Fair will be February 14th from 4:00 5:30 PM at the Cedar Rapids Public Library in the lobby.

V. Approval of Minutes from January Meeting

Commissioner Baumler moved to approve the January minutes as presented. Commissioner Jackson seconded the motion, and with no additional discussion, the motion passed unanimously.

a. Strategic Plan Working Group Reports

Commissioners Pantini and Jackson provided a copy of the draft strategic plan to commissioners during the meeting. She stated that the commission should be actively proactive in reaching out to the community, rather than being passive in allowing individuals or organizations to contact the group.

The Commission directed Ms. Kaufman to put together a calendar template that can be used as a working document, and should be continually updated throughout the year.

Commissioner Brazant discussed that her working group focused on ideas regarding future guest speakers.

Commissioners Vannatta and Gordon discussed three topics: 1. Presentations 2. Simulations 3. Street Team. They felt the audience activities would be best suited for already-formed groups, rather than doing a general community call-out. The presentations would be targeted toward service organizations. The street teams could participate at local community events. They felt the presentations should happen at least once per quarter, the simulations at least twice per year, and the street team activities, as often as possible. Commissioners Vannatta and Gordon asked that all commissioners try to commit to two events per year. They also discussed the possibilities of providing additional StarPower simulations throughout the community, and making slight adjustments to the game so it

could have a fair housing focus. This group also shared that they would prefer to keep the community outreach specifically focused in Marion right now.
