



Urban Farm Permit Instructions and Application

APPLICATION PROCESS

1. Review Chapter 340-9.33, Urban Agriculture of the Marion City Code regarding urban farms.
2. Prepare the required documents and drawings and submit via email to: planning@cityofmarion.org
3. The application fee for an Urban Farm Permit is \$30. Staff will communicate payment methods after confirmation that the application submission is complete.
4. There are also fees associated with obtaining a Conditional Use, Building Permit and/or an Electrical Permit, if any of these are required. These items can be addressed during discussion of your project with Planning Division staff.
8. Upon approval the issued Urban Farm permit will be mailed to the mailing address or emailed to the email address listed on the application.

MATERIALS TO BE SUBMITTED

1. This application completed in full and signed by the applicant and property owner.
2. A site plan of the property clearly indicating planting areas, footprint for all farm structures, existing structures, driveways, parking areas, and landscape buffers with dimensions and materials to be used.
3. Photographs of existing site and adjacent properties to provide site context.
4. Irrigation plan and controls for storm water runoff as required by the City of Marion.
5. Signage plan showing proposed signs, if applicable.
