I. Call to Order

Noting there was a quorum, Commissioner Jackson, Vice Chair, called the meeting to order at 6:30pm.

II. Roll Call/Introductions

Commissioners and staff introduced themselves.

III. Willis Dady Homeless Services, Aaron

Aaron presented information regarding their homelessness programs and statistics on the use of the Marion housing grant award stating that with the funds WillisDady was able to assist 13 households in Marion who were at the verge of homelessness. Of those households, two were elderly women facing eviction, seven households with 2-3 children, and two with five or six children. The organization is coordinating with and have gotten referrals from both Marion Independent and Linn Mar school districts and has a presence at the Marion Public Library on Wednesdays. The organization's services extend to case management for mental illness cases.

Commissioners Tibbets asked about permanent support housing services such as the Crestwood Ridge project in Cedar Rapids and the prospect of housing a similar project in Marion, shedding some light on chronically harmlessness and those with a high barrier to housing.

Abejo-Parker and commissioner Brazant spoke highly of the organization and expressed gratitude for the organization's exceptional customer service.

V. **Director's Report**

Abejo-Parker gave an update on the CRCRC Executive Director search. Position will remain open till filled. She talked about upcoming events and plans for impactful outreach strategies such as workshops to fill current gaps in the areas of housing and financial stability.

Commissioner Stoner moved to approve the November minutes as presented. Seconded by Commissioner Tibbets, motion passed.

Grant press release went out on Marion Messenger. Application is now open and will close on January 10th.

details. Commission is looking to cosponsor events at the library.

X. New Business

a. MCRC Election of Officers- Commissioners voted to approve Commissioner Brown for Vice Chair, nominated by Commissioner Brazant and Commissioner Jackson for Chair Commissioner, nominated by Commissioner Tibbets.

b. Upcoming Events

- ii. MLK Public Sector Job Fair- Event will be held at the Cedar Rapids Public Library 3 to 4:30 on Friday January 17th. Event is to encourage diversity in public sector employment.

XI. Good of the Order

Commissioner Rice invited the Commission to two special free screenings, a documentary on childhood anxiety with a facilitated discussion afterwards. Events will take place at the Cedar Rapids Public Library on Monday, Dec. 9, and Tuesday, Dec. 10.

Amal mentioned that the city is prepping for 2020 census and looking for volunteers to reach out to populations that historically have low participation rate and emphasize the importance of being counted. Especially, homeless, immigrants and those with language barriers, given recent federal policy who might be less inclined to participate in the survey.

Commissioner Rice moved to adjourn the meeting. Seconded by Commissioner Brazant, the meeting adjourned at 7:20 pm.
