#### I. Call to Order

Noting there was a quorum, Commissioner Jackson, Chair, called the meeting to order at 6:30 pm.

#### II. Roll Call/Introductions

Commissioners and staff introduced themselves.

#### IV. Director's Report

Staff continues to work remotely due to COVID-19.

As a follow up on the 21-Day Equity Challenge and in partnership with United Way, the department is hosting a series of equity conversations each Tuesday evening in February, from 6:30pm-8pm. Topics are based on United Way pillars: Feb 2<sup>nd</sup> about education, Feb 9<sup>th</sup> is about financial stability, Feb 16<sup>th</sup> is about health, Feb 23<sup>rd</sup> is about next steps, all towards creating a community of belonging. Commissioner Rice will be speaking at one of the events. Regarding intakes, the department referred one call to the state's civil rights commission.

#### V. Approval of Minutes

Commissioner Rice moved to approve the November minutes as presented. Seconded by Commissioner Forsyth-Christy, motion passed.

#### VI. Report from Chair

Commissioner Jackson urged commissioners to watch the national news and congratulated Commissioner Brown on winning a prestigious Collins Aerospace ACCEPT award for going above and beyond to champion an inclusive workplace. Acronym stands for: Affirming Culture, Creativity, Encouraging Pride, and Trust.

Commissioner introduced Angelica Vannatta to the commission.

Commissioner Vannatta expressed her eagerness and passion for serving as a commissioner.

### VII. Committee Reports

- a. *Executive Committee* Commissioners met on December 30<sup>th</sup> to set the agenda. The Committee discussed Community Equity Taskforce, LMI Housing Assistance Grant, and volunteer opportunities.
- b. Cedar Rapids Civil Rights Commission Liaison Renae Forsyth-Christy Dr. White was elected to be the Chair and Anthony has stepped down from the Commission in November. Keith is stepping down from Affordable housing committee and two commissioners will take the responsibility.
- c. Communication and outreach Committee -Commissioner Stoner Commissioner worked on a post promoting the Marion Low Income Housing grant and on FY21 plan for future engagements. Events were categorized into three major categories:
  - Read and Respond
  - Attend and Act

Commissioners discussed the need for revamping the events calendar plan. Commissioners will review the strategic plan to identify gaps and areas for improvements.

#### VIII. Unfinished Business

#### a. Community Equity Taskforce

Commissioners Brown briefed the commission stating that the taskforce, on December 10<sup>th</sup> meeting, reviewed the purpose statement, priorities, and core values. Initial focus will be on policy review. Commissioner engaged the commission in a discussion on priorities suggesting the commission leads focus group community conversations to inform the commission's priorities and focus. Discussion will continue to the next commission meeting.

#### b. Marion Low Income Housing Assistance Grant

Commissioners Brown stated that application deadline is February 12<sup>th</sup>. Commissioner commended Commissioner Vannatta for pioneering the grant initiative.

c. Events Planning: Item was discussed above along with community outreach committee report. Regarding MLK day, commission is planning on a mayoral proclamation and a social media post. Commissioner Vannatta invited the Commission to speak at the United-Way's equity conversations sessions.

#### IX. Good of the Order

Commissioners Rice shared that Black men of CR is hosting a webinar with Dr Reed around how to improve health outcomes for African Americans, extending his invitation to the Commission.

Circe Stumbo, through public comments, expressed gratitude for the commission's service and welcomed Commissioner Vannatta.

Commissioner Vannatta announced that United Way, as a part of the organization's priorities and commitment to social equity, added social impact volunteer award to its annual awards, recognizing those who strive to drive social equity through their volunteer work.
