Variance - corner side yard setback - Nelson

Public hearing regarding a variance request by Paul Nelson pursuant to Section 176.10-3.D of the Marion Code of Ordinances to reduce the required corner side yard setback of a primary structure at 5580 21st Avenue, Marion, Iowa.

Behrens presented the staff report.

Mr. Nelson, 5580 21st Avenue expressed his desire for additional garage space and that with the commercial property to the east the impact would be minimal.

There were no additional comments for or against the request. The public hearing was closed.

Mr. Nelson, stated that he believes that the commercial garages across the street were a bigger impact on the neighborhood than his garage addition.

Jordan indicated that she didn't believe a hardship has been presented that the Board could act on.

Golden stated that she concurred with the statements by other board members.
