# Discussion and direction regarding 958/960 and 976 7th Avenue / 710 10th Street Sanitary Sewer

City Engineer Mike Barkalow provided information regarding the sanitary sewer request from Nathan Caraway and School of Rock at the above referenced businesses. Staff is recommending an agreement similar to what has been offered to other uptown businesses during the 7th Avenue Reconstruction Project. Councilmember Brandt asked for the cost of recommended option. Barkalow stated the project would cost \$15,000 with

City paying a portion. Mayor AbouAssaly stated that the recommended option seems the most fair.
