### 1. Purpose

There are circumstances in which it is in the best interest of the City to participate in cost sharing for public improvements associated with private development projects.

The purpose of this policy is to have a consistent way for developers to submit their requests for cost sharing for public improvements to the City so that the City can process these payments with the required information. Developers may submit requests for anticipated future costs or for reimbursement of costs already incurred.

## 2. Applicability

This policy applies to all projects in which a developer/owner wants the City to participate in the cost of public improvements.

City Council has set forth certain public improvement costs that are eligible for cost sharing. Current eligible costs are:

- 1. Overwidth of subgrade prep
- 2. Overwidth of subbase and geogrid
- 3. Overwidth and overdepth of paving for streets and trails
- 4. Sanitary sewer oversizing above 8" diameter to serve offsite land.
- Storm sewer oversizing above 36" diameter along City identified Major Streets
- 6. Any other cost authorized by City Code or Policy

#### 3. Procedure

The Developers shall submit the "Application for Cost Sharing for Public Improvements Associated with Private Development Projects" along with all applicable supporting information.

No cost sharing or reimbursement will be approved without having the application filled out fully and all supporting information submitted. Any application which is not filled out completely or which does not provide the required supporting information may be rejected. Applicants may correct any deficiencies in the application or supporting information and resubmit a rejected application.

City staff will review the applications to determine if the requested costs are eligible for cost sharing under this policy and if funding is available in the requested fiscal year. If funding is not available, costs may, at the discretion of City Council, be deferred or delayed at no cost to the City.

City staff will present all applications and staff recommendations to City Council for approval or denial. Approval or denial shall be at the discretion of City Council.
