- The deadline for Planning and Zoning Commission submittals is the first business day of the month for the following month's meeting.
- City staff will meet on the Thursday after the first Council meeting to review submittals.
- Review meetings with applicants will be held on the Wednesday following staff review meetings.
 - The location of these meetings will be communicated to applicants as they are scheduled.
- Revisions are due by the last business day of the month.

Zoning Board of Adjustment:

- The Zoning Board of Adjustment meets at 7:00 p.m. on the third Tuesday of every month.

• The Historic Preservation Commission meets at 7:30 a.m. on the second Tuesday of every month.

Marion City Council:
