MISD's High School Auditorium addition has been completed except for some exterior items to be completed in the spring. Linn-Mar's Performance Venue addition contactor has set precast walls and is finishing up groundwork inside before closing it completely up for the winter. Their administration building has an occupancy and has a short punch list they are working to complete. The Holiday Inn Express has an occupancy for much of the building, they do have a few rooms missing plumbing fixtures because of a product delay. Projects well under way are East Town Apartments and Shadow Ridge Apartments which is a mixed-use building and will have retail on the first floor. Two new projects are Freddy's restaurant in the East Town Crossing area, and a restaurant to be named in the Indian Creek Mall area. With items that are coming in for planning reviews, that will likely have permits in the spring, it looks to be another busy year.

Planning & Development Updates:

- Comprehensive Plan RDG Planning and Design has been working on all aspects of the Plan in the background. The Technical Team met on November 18, 2024 and walked through the draft document. Staff started the deep dive into reviewing the document and will continue communication with RDG regarding edits. An open house was held on December 10, 2024 with approximately 23 attendees providing comment to elements of the plan that will be reviewed staff. Public comment period is open and will remain open through January 2025
