

# MINUTES City Council Regular Session

5:30 PM - Thursday, April 3, 2025 City Hall, 1225 6th Avenue

The City Council of the City of Marion, Linn County, Iowa met in regular session, on Thursday, April 3, 2025, at 5:30 PM, in the Council Chambers of City Hall, 1225 6th Avenue, with the following members present:

Mayor AbouAssaly presided over the meeting.

The meeting opened with the pledge of allegiance and Council observed a moment of silence.

# Proclamation - Week of the Young Child (April 5-11, 2025)

Mayor AbouAssaly read and presented the proclamation referenced above to Tammie Tomash with Iowa Association for the Education of Young Children.

## **Proclamation - Fair Housing Month (April 2025)**

Mayor Pro Tem Miskimen read and presented the proclamation referenced above to Renae Forsyth-Christy with the Marion Civil Rights Commission.

### **PRESENTATIONS**

## Annual Presentation of the Marion Civil Rights Commission

Renae Forsyth-Christy with the Marion Civil Rights Commission provided an overview of the Commission as well as the 2025 outreach initiatives including minority owned business data collection, hosting public forums and outreach event participation. Councilmember Jensen stated he is happy to hear the Commission will be focusing on Marion events.

# **Update to the Neighborhood Park Master Plan**

Scott Crawford with RDG Planning & Design reviewed concept plans developed with feedback from residents and the Neighborhood Park Steering Committee at the Lucore Park Property, Waterlinn Park Property and Willow Park. Next steps were provided including additional meetings with the steering committee and City staff, a review by the Park Board and a final presentation to City Council. Councilmember Harper asked if placement of the trail could be separated further from the placement of water tower. Parks Director Seth Staashelm stated they will take that feedback into consideration. Councilmember Jensen asked about ballfields at the parks. Staashelm stated the

locations aren't ideal for ballfields and the team will see if there is similar feedback at the open house. Councilmember Jensen asked how these parks will be prioritized. Staashelm stated at the next Steering Committee meeting, phasing will be discussed.

# Discussion Regarding Design Standard Updates and Use Standards

Charlie Cowell with RDG Planning & Design reviewed the target corridors and intent of this process. Feedback from the open house on March 26 was shared including proposed prohibited uses along Tower Terrace Road, Business Highway 151, Highway 13 and Central Corridor Districts. Councilmember Jensen stated he would like to limit the distance between liquor, smoke and vape shops along Central Corridor and Highway 151 in addition to what was proposed. Councilmember Mentzer spoke about convenience stores and gas stations along Tower Terrace and would like to somehow require more than the minimum convenience store and have a grocery component included. Cowell outlined landscape and architectural standards such as materials, scale and design. Sign standards were also discussed. Deputy City Manager Kim Downs stated if anyone has additional input to provide, to submit that to the Planning Division. Mayor AbouAssaly thanked everyone who has helped with this process to date.
