## Art in the Alley

Karen Hoyt shared with the Art Council that the Art in the Alley committee raised \$170,000. The goal was to raise \$130,000. They will be able to do extra things with the extra money raised. Amanda Kaufman, Assistant to the City Manager, and Karen Hoyt shared with the council samples and models of the Art in the Alleys project. Infrastructure work shall begin as soon as the ground thaws and needs to be completed by October 28, 2016 and liquidated damages will apply in the amount of \$1,500 per day for each calendar day in excess of this schedule. The committee has heard back from IEDA and only 2 of the art pieces that immediately touch a historic building needs to go through SHPO review. Once the contracts are approved, the Art in the Alley committee can share the specifics of the art pieces and artists.

# Sculpture Trail Committee Update

The Sculpture Trail Committee will consist of Katie Lowe Lancaster, Bob Naujoks, Jay Moore and Marge Jensen. Brenda and Pat will be the MAC members. Brenda is working on the contract for the sculpture trail and will contact the committee members with a timeline and meeting dates. The sculpture Liberation, referred to as "snowplow", was originally intended to sit off of the main trail with the top visible from the main trial. The size of the sculpture was to fit in with the landscape and not over power it. It was intended that there would be pieces such as this that would have paths cut in the grass so people could wander off of the main trail to visit the sculpture closer. It was mentioned the "snowplow" art piece is small and not visible where it is located. This piece could possibly be moved to a different location and replaced with a larger art piece.

The February exhibit is from Mt. Mercy University. Kirkwood and Cornell College were unable to exhibit with Mt. Mercy. The local school exhibit is from Wilkins Elementary. Mt. Mercy's reception will be February 11 from 6:30 to 8. Fuf, Brenda and Pat will be able to help at this reception. Wilkin's reception will be February 16 from 5:30 to 6:30. Fuf and her granddaughter will be able to help at this reception. Barb Weeks-Caudill and Jefferson Henshaw will be at the March/April exhibit. The art exchange will be on Saturday, March 5. Fuf will be able to help at the exchange. Everyone will check their calendars to see if they are available to also help that day. The May/June exhibit will be by Rock Tai and Cris Sell. The July/August exhibit will be Tamera and Brian Jensen. The September/October exhibit will be Dianna Dunn and Jan Bell. The school exhibits scheduled are March: Linn-Mar High School; April: Bowman Woods and May: Oakridge Middle School.
